# Regulations concerning the Deadline for the Payment of Usage Charges

Established on April 1, 2019

Last revised on April 1, 2023

#### Article 1. Purpose

These regulations specify necessary matters relating to the deadline for the payment of usage charges, etc. by operators in the airport in accordance with Paragraph 1 of Article 15 and Paragraph 1 of Article 15-2 of Fukuoka Airport Service Regulations (hereinafter referred to as the "Regulations").

# Article 2. Designation of Deferred Payment

- Notwithstanding the provisions of Paragraph 1 of Article 15 and Paragraph 1 of Article 15-2 of the Regulations, those designated in advance by FIAC may make deferred payment of the monthly charges in a lump sum by the deadline set by FIAC.
- 2. Those designated to make deferred payment under the provisions of the preceding paragraph shall pay usage charges, etc. by bank transfer in principle; provided, however, that they may make payment by cash or in other methods if they have gained approval from FIAC accordingly. The fee for the payment shall be borne by the operators, etc.

#### Article 3. Rescission of Designation of Deferred Payment

- When those designated to make deferred payment as provided in the preceding article fall under any of the cases listed in the following items, FIAC may rescind the designation.
  - (1) A petition for the execution of a provisional seizure, provisional disposition, compulsory execution, auction, etc. is filed, a security interest is exercised or other preservation measures are taken.
  - (2) A petition for bankruptcy, reorganization, civil rehabilitation, etc. is filed or they go into liquidation or are subjected to a suspension of bank transactions.
  - (3) A ruling of the commencement of guardianship or the commencement of curatorship is received (for a legal person, the representative has received such a ruling).
  - (4) A trustee is appointed due to a court order or other reasons.
  - (5) There is a delay in the performance of obligations to FIAC or failure of the performance of other obligations or an extremely serious impediment to the performance of obligations is likely to occur due to deterioration of the financial condition.

- (6) For air carriers, they are ordered to suspend the business or the business license is revoked.
- 2. If the designation of those designated to make deferred payment is rescinded under the provisions of the preceding article, they shall forfeit the benefit of time and pay the whole of the obligations accrued by using the facilities provided by FIAC (excluding the obligations accrued under any land or building lease contracts and any contracts incidental thereto) by the date designated by FIAC.

Article 4. Deadline of the Payment of Usage Charges by Operators, Etc. of Irregular Flights

- Any operators, etc. of irregular flights not designated under Paragraph 1 of Article
  of the Regulations shall pay usage charges, etc. to FIAC by the time when the aircraft operated by them take off.
- 2. In the case of the preceding paragraph, if multiple flights are scheduled in a given month, FIAC may issue a bill to the Operator to demand payment of the Airport Fees for that entire month before the first flight in that month takes off. Upon receiving the bill, the Operator must pay the Airport Fees to FIAC by the date specified by FIAC.
- 3. The payment stipulated in paragraph 1 or the preceding paragraph must be made by bank transfer. If the Operator obtains the approval of FIAC, the payment may be made by cash or any other approved method. If any difference from the actual amount of usage charges, etc. arises, FIAC shall settle the amount and return the difference or demand additional payment of usage charges, etc.

Article 5. Application Mutatis Mutandis to the Charges Specified in Paragraph 3 of Article 15 of the Regulations

The provisions of Article 2 or 4 of these regulations shall be applied mutatis mutandis to the deadline of the payment of the charges specified in Paragraph 3 of Article 15 of the Regulations.

### **Supplementary Provisions**

These regulations shall come into effect on April 1, 2019.

These regulations shall come into effect on April 1, 2021.

These regulations shall come into effect on April 1, 2023.
